The North Dakota Grocers Association will award several scholarships for the academic year beginning this fall. Each \$1,000 scholarship will be awarded to the children of full-time employees as well as part-time employees who are full-time students.

WHO IS ELIGIBLE?

2018 High School seniors who are:

1. Sons and daughters of full-time employees of firms which are members of the North Dakota Grocers Association. The parent employee must have been employed for at least two years as of March 9th of the year in which the scholarships are awarded.
2. Part-time employees who are full-time students and are employed by firms which are members of the North Dakota Grocers Association. Applicants must have worked an average of 10 hours per week for at least 12 months as of March 9th of the year in which the scholarships are awarded.

NOTE: The applicants or the parents of applicants must still be employed by a dues-paying NDGA member firm at the time the winners are announced.

Scholarship winners will be selected in April. Winners must enroll in college as full-time students in the fall.
