

Grocer of the Year



The North Dakota grocery industry's highest honor, the NDGA Grocer of the Year award, is presented annually to recognize an individual or individuals for their achievements within the grocery industry. These honorees exemplify the highest qualities of leadership in business and their community; their influence has positively enhanced the lives of others.

Excellence in Operations honorees are recognized for their work ethic, commitment to the grocery industry, and for efforts that have positively influenced their company, associates, and customers.

Now, it is easier than ever to submit your nomination: To place your choice for consideration for either the Grocer of the Year and/or Excellence in Operations award, just submit one nomination (see criteria questions on following pages) and send it to NDGA. We'll do the rest!

All nominations will be scored for both the Grocer of the Year and Excellence in Operations awards. The highest scoring nominee will be recognized as the Grocer of the Year. The remaining nominee will be considered for the Excellence in Operations awards.

How to Nominate

To nominate a candidate for NDGA Grocer of the Year and/or Excellence in Operations, fill out the form and return it to NDGA by Friday, June 21, 2024. You may nominate online at ndgrocers.com or by submitting forms by mail or email to jiggsdyste@gmail.com.

Selection

The NDGA Board of Directors will score all nominations. The top-scoring nominee will be the Grocer of the Year and the rest will be considered for the Excellence in Operation Awards.

Recognition

The recipients of the NDGA Grocer of the Year and Excellence in Operations awards will be notified in July/August 2024. Each award winner will be celebrated at their business and will be feature din the NDGA Newsletter and on ndgrocers.com. Honorees will be recognized at the Chairman's Banquet during the Annual NDGA Convention.

Eligibility

The nominee must have made outstanding contributions to the grocery industry, provided opportunities for their associates, been involved within their community and have a history of active support and involvement in the NDGA. The nominee may or may not currently work in the grocery industry. The nominee's company must be a current dues-paying member of NDGA. The recipient should attend the Chairman's Banquet during the Annual NDGA Convention on October 15-16, 2024 at the Delta by Marroitt in Fargo, ND.
